PEOPLE BEHIND FALSE IMPRISONMENT

PART 1

Part one of this complaint details the reasons for this my seventh false imprisonment, and a short account of the corrupt activities of the people involved, and their positions in the justice system.

John L Murray Chief Justice is named in my High Court Plenary Summons 2007/9400P. This case took eighteen days, six judges perverting the course of justice in colluding with the Chief states solicitor, who had his own High Court stamp as the correspondences I was getting said appearances were lodged on behalf of his clients and were High Court stamped. When I checked with Central Office, no appearances were made. This was all brought to his attention, but not even an acknowledgement. Many times since I started this campaign for justice I have brought things to the attention of that office.

The most recent encounter took place after a friend came to me and said he was having difficulty with a case he had going on with McBride Conaghan in Moville, "Judge McBride's old practice". This case started off without a problem, but suddenly he was asked for €5,000 upfront, and this happened after he met a barrister. The reason for the blockage was that the garage who were defendants, were also the agents for the insurance company that Sean McBride when working as a solicitor was known to be one of the best for false insurance claims. He had four doctors in Letterkenny, one in Sligo and two in Dublin that were writing up reports, saying people were seriously injured, some of these patients they never saw. One of these cases had a quarter of a million Euro lifted, and the legal fees were not yet ascertained. The owner of the garage lives beside Judge Michael D. White's home place. I told my friend this was the problem, and he reported the Solicitors to the Law Society, and the Barristers to the Bar Council. The Law Society returned it to sender, the Bar Council said they would hold an enquiry. A full copy of the file was then sent to Chief Justice John L. Murray along with the evidence of the insurance case I mentioned, plus the evidence of the midnight courts set-up by Judge Michael D. White and his brother Philip solicitor, Court staff Geraldine Ó Connor and Val Cronin Letterkenny, and Prison Authorities Castlerea Prison, and other perversions of the course of justice in Carndonagh District Court. (Their home town). Twice the Chief Justice returned the documentation, the second time he said he was having no further correspondences. In my friends last letter dated 14/01/2011, it stated that as he said he wasn't going to respond any further to take this as a twenty one day warning letter, as proceedings were going to be issued against him and his accomplices. The threat of proceedings was enough to put the corrupt circle into action, and was enough to put me in solitary confinement, and being denied my basic human and constitutional rights and medical care. That corrupt circle includes the management and staff of Castlerea Prison.

My first encounter with Judge Michael D. White Circuit Court was back in 1985. My land deeds were in his office for safe keeping as I thought, since 1981. I returned from England in 1985 and I just called to his office to check my deeds. His brother Philip wasn't too forthcoming, but after a few visits he eventually told me they were in A.I.B. Bank Moville as collateral for a loan, and more or less told me to leave. I spent years between reports to the Law Society, Bar Council and a High Court case that the solicitor who took it for me told me I was on my own. That case disappeared and it wasn't until I got in touch with a group called the "Victims of the Legal Profession" that I discovered what the problem was. Judge Michael D. White, Circuit Court, and now member of the Court Services Board, was well known for corruption and bribery. However it wasn't until I met his neighbour that the full extent of his corruption appeared, that along with his many midnight courts is enough to show that John L. Murray and many others in "positions of trust" have betrayed them.

first got involved with Judge Sean McBride in 1992, after he took £30,000 under the table, from a person who had no egal entitlement to a farm, and put the man he was working for and paying him, out to the street. The Fraud Squad, the Law Society and the Land Registry did nothing. Judge Mc Bride eventually got an injunction on six people for life by the High Court, for a peaceful protest outside his office. Judge McBride while working as a solicitor, his corrupt Garda riends in Moville and Buncrana Garda stations, court staff at Circuit and District and Governor Scannell and Officer Cilbana were holding me on the same made-up warrants as these ones. Habeas Corpus applications, "which means roduce the body" that came to nothing were coming back to me in prison with Judge Hanna's name on them. Judge Hanna is a brother in law of Judge White, which says it all.

SUMMARY OF IMPRISONMENT

09/02/2011

PART 2

Summary of events since one o'clock Sunday 06/02/2011

Serg. Lynch and Garda Canning called to my home in relations to outstanding warrants, which I knew nothing about. I asked to see the warrants but they refused and demanded £3,000 immediately, or I was going to prison. I told them I was ready any time, but they said it would probably be Tuesday. Sometime later I phoned Buncrana station and told them to tell them to phone me back, which they did, and Garda Canning did an said he would arrange for me to see them tomorrow, but nothing happened until they arrived at nine o'clock on Tuesday 8th February 2011 and told me to get ready for Castlerea. On Monday morning 7th February 2011 I faxed a two page complaint with twelve supporting documents to Garda Commissioner Callinan. I later spoke to Serg. Sean Ó Riordan who confirmed he received it, and would bring it to the commissioner's attention immediately. Back to Tuesday, they said they were going to arrest me, I told them to go ahead, but they wouldn't and then called for backup which arrived as we were leaving. At the station I asked to see my warrant and make a complaint, but all was refused and I got into the waiting taxi.

On arrival at Castlerea Prison an officer asked me was I aware of what I was in the warrants. I told him I wasn't, as I wasn't in court or seen the warrants. He said he had a genuine warrant and I had enough time to pay. At reception the officer who processed me through, said he was giving me my old prison number from 2006, and gave me a remand card. When I asked him about this, he said he hadn't seen the warrant, but he knew I was on remand.

In the governor's office on Wednesday 9th February I was told I was sentenced and the warrant related to 2001, I said all those would have been dealt with in 2006. I requested a Habeas Corpus form and a copy of my warrant. An officer brought the form shortly after without the warrant. I told her I couldn't fill the form without the warrant. Well on in the afternoon an officer came with a document and asked me to accept this as a true copy of my warrant, I asked where was the back and he walked away and said the chief could deal with it. Shortly after this the officer who sat beside the governor came with two documents and showed me a scribble of the Garda name who executed it which no-one could make out. When I examined the warrant they had changed it to offences relating to 2007. This would explain the delay in giving it to me. The medic took all my details and noted the names of my eye drops, four in all.

On Thursday 10th February 2011, I gave my Habeas Corpus form to the governor, who said she would send it to the High Court personally. After dinner I was taken to an isolation cell, which has no radio, t.v. or electric kettle and very cold. All I asked for was a cup and a pen. The officer wouldn't give me a cup and a pen wouldn't write. A very bright light was kept on all night which kept me from sleeping. A kindly officer gave me a paper which meant a lot. Friday 11th February 2011, the doctor called and asked did I get my eye drops, she said she prescribed them all on Wednesday. After this the officer told me to pack up my kit as I was being moved. They told me this was where people on remand were kept. I was put into a waiting room with another person. Soon after this they took him out, and I was left for a while before being told to bring my kit and I was brought back to where I left. Shortly before this I was asked to take a visit and filled in a form. There was a form relating to phone numbers. I had explained to the governor the numbers I needed were in my bag at reception, she said I would be brought there for them, but it hasn't happened yet. I was told the governor was coming which never happened. The visit never took place. Later the medic called with eye drops, but they were a duplicate of what I had got. I got them to put out the light, and shortly afterwards very loud piercing music started and went on all night. I got no sleep, and still haven't got soap.

Saturday 12th February 2011, the doctor called and asked had I any problems, the officer with him is a gentleman and has managed to get me all I was promised for the last three days in half an hour. Still haven't got all my eye drops.

Sunday 13th February 2011, I asked to go to Mass and the officer said he would have to see the governor as I was in dispute. Later I was taken to Mass, which was started when we got there. I was put into a seat on my own at the back, when Holy Communion was about to start, the officer said if I wasn't going we would leave. I managed to get reading material that will help pass the time, and when we got back to the cell I noticed my name card had been changed from remand to sentenced. (Without Court) The medic called tonight to say my eye drops will be here tomorrow. Very loud music and bright light on all night. No sleep for four nights, and haven't eaten since Monday night 7th February 2011.

Monday 14th February 2011, No food put into cell this morning, medic called about eye drops, and later the governor came, I asked was I in solitary confinement, he said not necessarily, but as I was on hunger strike I had to be segregated. I asked again for a copy of the prisoners rights, which has been promised since I came in. I asked what was happening with the Habeas Corpus and he said it was up to the courts and walked away. He knows very well that an order like this says you have to have a hearing within five days. A medic called an took my blood pressure, he never said what it was but asked did I suffer from high blood pressure although I feel fine. The medic didn't call on her rounds, still no drops.

Tuesday 15th February 2011, The medic called early and took my blood pressure, he gave me one of the promised drops, and said the other was on order. The one I am not getting is the most important as it keeps my operation successful. The governor called and I requested to see the visiting committee. After checking the drop I got it isn't the same as I was using. The drops they are keeping off me are the ones that will do most damage to my long term health. This is organised by someone who knows what they are doing. I was taken for a visit and when the officer was letting me into my cell, he said he was onto the medic and my drops had to be imported from England. The doctor and a nurse call and said she prescribed all my medicine last Wednesday.

Wednesday 16th February 2011, The medic called with one of the drops that was supposed to be coming from England, the date on the sticker says it was got in the local chemist the day before. Later the governor called and I again requested a copy of the booklet of prisoners rights. Sometime later a nurse called with another story about the last drop I have to get, we ended up by waiting to see what the doctor says when she comes round. In the meantime I have received a prisoner complaint form. The doctor came and there is another story about drug licence. She ended up by saying she would prescribe the same drop under a different name. A nurse has called to say the drops were here and the medic would bring them, The medic has just called and said they are coming from England.

Thursday 17th February 2011, A nurse called and told me the drop I am waiting on can't be got in this country. The governor called and has given me more time to complete my complaint form, and I brought to his attention again that I still hadn't got the last of my drops. The doctor has just called, and the nurse that called in the morning with her. I brought up the story of my missing drops, and the doctors story contradicts the nurses. The nurse who called this morning and later with the doctor has called again with a box out of Kearney's Chemist Castlerea dated 14th February 2011. The small writing on the label says Muro ointment, on larger print below it says instill two drops into eye three times daily, I was on Muro drops not ointment. This shows the pharmacy was facilitating them all the time, the same nurse has just taken my blood pressure.

Friday 18th February 2011, Breakfast put into cell but not taken out. No drops that are kept across the landing from the cell. Governor called and I tell him I am not getting my drops. Another medic has called with a different story about the drops. Later an officer calls and takes away my razor. Later I hear the doctor outside the door, but hasn't come in. Later a medic called and took my blood pressure. I tell him about the drops and said I would get them tonight. I heard the medic outside the door but didn't come in. Eye painful. Asked twice to have the light off, but was refused.(No sleep)

Saturday 19th February 2011, Breakfast put into cell. Later a doctor and a nurse called, and I again tell them about not getting my drops, and they said they would do something about it. The governor called and I tell that I still haven't got the drops. Shortly afterwards a medic took my blood pressure, and told me the drops had to be ordered even though there is half a box sitting in the office. Nobody came back to the cell and after asking for the light off it never happened. Still on hunger strike.

Sunday 20th February 2011, Went to mass. Later a medic called and said he was looking into my missing drops. It is now bedtime and no one has come near my cell. My drops which should have been simple, has shown that from the chemist to the doctor have been telling lies, in order to damage my long term health, because I wont bow to their "Corrupt Authority". No clean clothes or kit since 8th February 2011.

This is a continuation of my prisoner complaint that was given to the governor on 20/2/2011. I have made several

requests for another complaint form without much joy, so this is a follow on of the first one.

On Monday 21st February 2011, the doctor called and said my eye was badly inflamed, and she said she was going to get me the drops. I was taken to see the psychiatrist, in the short time I was with the psychiatrist I told her I had no problem with the hunger strike, but the withholding of my drops was making my eye very painful and the fact the light was on all night made it worse. After this a nurse gave me one of the missing drops. I also got a change of clothes.

Tuesday 22nd February 2011, Governor called and I bring the problem of the missing drops to his attention, later I get my Muro drop, but no copies of prisoner complaint form, but light off early.

Wednesday 23rd February 2011, Doctor called, and later nurse took my blood pressure. Governor called but still no photocopies of prisoner complaint form.

Thursday 24th February 2011, Governor called with my photocopies and I bring to her attention that I wasn't getting my drops. Got a letter from the High Court dated 17/2/2011 and postmarked 18/2/2011. Still no drops. In the afternoon I was moved to a much more comfortable cell that is much warmer. I was given all my drops and when I looked at the dates on the boxes they were all in the prison during the time they were telling me they had to come from England.

Friday 25th February 2011, The governor called and talked about coming of the hunger strike, later a medic called and and took my blood pressure.

Saturday 26th February 2011, Got a change of clothes, my eye very sore this last few days.

Sunday 27th February 2011, Went to mass and Holy Communion which breaks the hunger strike.

Monday 28th February 2011, Governor called, and later the doctor came and told me to eat slowly and small amounts. I requested to be released on medical grounds as my eye had deteriorated badly from not getting the drops. I was moved back to an ordinary cell that day.

Tuesday 1st March 2011, Got a visit and all the local papers were never passed on to me.

Wednesday 2nd March 2011, Still waiting on writing paper and jacket for going to the yard.

Thursday 3rd March 2011, Got my jacket, and was taken to meet the visiting committee which was a waste of time. They didn't have any knowledge about the prison rules or the courts. The governor wanted to sit in, and it was obvious that my case was discussed beforehand as they made reference to my eye drops having to come from England. The officer from the office sat in during the meeting. To me, these people are run by the governor's.

Friday 4th March 2011, Saturday 5th March 2011, Sunday 6th March 2011, Monday 7th March 2011

Tuesday 8th March 2011, My visitor asked could he see the governor about getting a copy of my warrant to bring to a solicitor. Shortly afterwards an officer came to the visiting box with a printout from an e-mail from the High Court, saying my case was ruled on by the High Court and I would be notified by the governor. He also said that I was to request a copy from the governor. Despite requests by half sheet, verbal and through the officers "nothing".

Wednesday 9th March 2011, I went to see the doctor who referred me to the optician who was here that day. The optician said I needed to go back to where I got my operation done as my eye had deteriorated. Shortly after this a nurse came to me with a form to sign that I would be going under escort. I didn't sign it as I felt had I been given my human and constitutional rights I would have been released.

Thursday 10th March 2011, I went to see the doctor about getting another months supply of drops. That night I got some but two were missing. I was told they had come from England, next morning they were handed to me. Still no

word about the High Court case.

- Friday 11th March 2011, I have again written to the governor's requesting copy of warrant, prisoner complaint form and copy of letter dated 27/2/2011 and this one.
- Saturday 12th March 2011, Still no word about what happened about my Habeas Corpus in the High Court.
- Sunday 13th March 2011, Still no word about the court case.
- Monday 14th March 2011, I have made enquiries about the court case through an officer, who said he would get back to me in the afternoon, but he never did.
- Tuesday 15th March 2011, Still no word from the High Court.
- Wednesday 16th March 2011, I went to an officer this morning and told him about not getting my High Court order, the amount of the fines that was still due and why was I not given a chance to pay some of fine off. I also told him that I hadn't got the outcome of the complaint I had made on the 20/2/2011, and that I was still waiting on the Garda to come as I had requested this off the governor days after I came in.
- Thursday 17th March 2011, This evening an officer brought me a letter which was from the High Court. It had a hand written address and was postmarked in Dublin 15/3/2011. It said that my Habeas Corpus was ruled on 01/03/2011, which was refused and my presence wasn't required in court. The judge was Ms. Justice Dunne and the registrar was Mr Griffin, both were involved in perverting the course of justice during my High Court plenary.
- Friday 18th March 2011, I wrote to the governor's again, but no reply to anything.
- Saturday 19th March 2011, I was called to see the governor around 11 o' clock, and they told me my mother was dead. They asked did I want to make an application for temporary release. They said there was no guarantee I would get it, nor did they know if I would be going on my own, or under escort, and that everything relating to release had to go through the Dept. of Justice. One of these two people was the one who changed my warrant (or got it changed) from 2001 to 2007, and sent another officer to get me to accept it as a genuine copy of my warrant. He came later with it in two parts. I explained that if I had got my human and constitutional rights I would have been at home, as they knew I was in prison on false documents, and if I had to grovel to someone as low as them I would be staying away. Needless to say I didn't make an application.
- Sunday 20th Monday 21st March 2011, After dinner on Monday I was given a copy of my letter dated 18/3/2011, no appeal papers for supreme court.
- Tuesday 22nd March 2011, Got a change of clothes, on the way back an officer asked me did I get correspondences from the High Court, and the governor told him there wasn't any paperwork to appeal a case to the supreme court. I insisted that it was only two forms that could be faxed from the court on request. I also brought it to his attention that I had made several requests to the governors, and other officers to get the Gardai in, so I could make a formal complaint.
- Wednesday 23rd March 2011, I was called to see the governor and I was given the appeal forms, which I got filled and returned.
- Thursday 24th March 2011, Got a copy of the Supreme Court form, and he said they were posted by registered post which I had to pay for myself.
- Friday 25th March 2011, An officer told me my neighbours phoned and wanted to visit me. I told him that when I went on hunger strike I got no phone calls and was told that I would have to apply to the governor to get them back and I was only allowed one visit. I told him I had been denied everything I was entitled to up to this, and I had no intentions of going back to look for anything more.

Saturday 26th March 2011, I requested a breakdown of my fines, a copy of my warrant, copies of my appeal forms, and when the visiting committee were sitting again, but no-one came back to me.

Sunday 27th and Monday 28th March 2011, I asked an officer to find out my release date and a copy of the Supreme Court appeal. He came back later and said that I was due out on 15/4/2011, but had no word on the Supreme Court appeal.

Tuesday 29th March 2011, I got the registered post receipt, enquired again about meeting the Gardai. I got a reply from the Supreme Court that is dated and postmarked 28/3/2011 and states that this matter is receiving attention.

(Wednesday 30th March – Tuesday 5th April 2011) Wednesday 6th April 2011, Got a summons today for court in Carndonagh for 19th April 2011. A Garda called Dara Lyons from Castlerea gave it to me. I asked him why did he not come to take my complaint, as I had requested a visit through the governor on several occasions, he said he never heard of it. I wrote to the state solicitor and asked for this case to be postponed until July.

Thursday 7th April 2011, I asked an officer this morning when the visiting committee were sitting again. I had my name down shortly after they sat in March, he came back in the afternoon and said he wasn't sure. On the way out to the yard I asked another officer, who said they sat today. I again asked about the Gardai coming to see me, and he said he would look in to it, but he didn't come back to me either.

(Friday 8th, Saturday 9th, Sunday 10th April 2011) Monday 11th April 2011, The result of the so called Supreme Court case was given to me today. This came by fax and states 7 pages including cover sheet. I received 5 including cover sheet. It says the appeal was heard on 08/04/2011 and was dismissed, and that my attendance in Court was not necessary. There were only two pages involved in making this appeal, and no supporting documentation went with it. This was done just like the High Court case, "a deliberate perversion of the course of justice"

Summary of events since 7th February 2011.

On Monday 7th February 2011 I faxed 12 documents to Garda Commissioner Callinan that dated back to my first imprisonment in 1994. I had some correspondences with him after I came in here. Then everything stopped, and on Wednesday 6th April 2011 the Gardai who were to come and take a statement of me, instead came and gave me another summons that was made up by the same people who I had complained about.

The management and staff of this prison have colluded with the corrupt judges, court staff and Gardai in falsely imprisoning me on fabricated documents which is the way things are done in our justice system today, and proves that our legal and justice systems are only fronts for "Greed, Corruption and organised crime operated by traitors in positions of trust".
